A Bachelor's Degree in Travel / Tourism Management / Tourism Administration from a recognized University.

Or

A Bachelor's Degree from a recognized University with Post-Graduate Diploma in Travel / Tourism Management / Tourism Administration.

AGE: Not more than 39 years on 01.01.2019.

Fee: Rs. 160/- (Rupees one hundred sixty) only. In addition to that, the candidates will be charged as follows:

- (i) For online payment through debit/credit cards: Convenience fee 1% of the examination fee subject to a minimum of Rs. 5/- (Rupees Five) only plus 18% G.S.T. on convenience fee.

- S.C./S.T. candidates of West Bengal and Persons with disabilities (P.W.D.) having physical disability of 40% and above are not required to pay any fee. INFORMATION

- 1. SUBMISSION OF MORE THAN ONE APPLICATION FOR ONE PARTICULAR POST IS STRICTLY FORBIDDEN. THE CANDIDATURE OF A CANDIDATE WHO SUBMITS MORE THAN ONE APPLICATION FOR ADMISSION TO THE SELECTION PROCEDURE, WILL BE CANCELLED EVEN IF HE/SHE IS ADMITTED TO THE SAME.
- 2. The qualifications prescribed in the advertisement are as per the notified recruitment rules issued by Government.
- 3. All the degrees/diplomas/certificates mentioned in the advertisement must have been obtained from recognized Universities/Institutions.
- 4. The prescribed 'qualifications' are the minimum and mere possession of the same does not entitle applicants to be called in for the interview. Where the number of applications received in response to the advertisement is large and it is not convenient or possible for the Commission to interview all the applicants, the Commission may restrict the number of candidates for interview to a reasonable limit on the basis of higher standard of marks/grade obtained in the essential qualification or on the basis of a Screening Test/ Written Test.

The Commission may fix qualifying cut-off marks for all the categories of the vacancies in each level of examination, i.e. written, interview and aggregate.

- 5. Besides pay, the posts carry allowances as admissible.
- 6. The benefits of reservation of vacancies and upper age concession upto 5 years are admissible only to S.C. and S.T. candidates of West Bengal and upto 3 years to O.B.C. (category 'A' & 'B') candidates of West Bengal. S.C., S.T. and B.C. candidates of other States may apply for unreserved vacancies as general candidates. Such benefits are also available upto the age of 45 years for Persons with disabilities.
 - (a) A candidate claiming to be S.C., S.T., B.C., B.C., (Non Creamy Layer) or persons with disabilities (40% and above) must have a certificate issued on or before closing date of submission of online application in support of his/her claim from a competent authority of West Bengal as specified below:

For S.C., S.T. and B.C. candidates:

- (i) In the district, the Sub-Divisional Officer of the Sub-Division concerned, and
- (ii) In Kolkata, the District Magistrate, South 24-Parganas or such Additional District Magistrate, South 24-Parganas, as may be authorized by the District Magistrate, South 24-Parganas, on behalf and the District Welfare Officer, Kolkata and Ex-officio Joint Director, Backward Classes Welfare.
